

Official proceedings of the City Council of the City of Marseilles of the meeting of July 7, 2021.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on July 7, 2021.

Moved by Commissioner Kaminski seconded by Commissioner Lewey that the minutes from the Council meeting of June 16, 2021 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the accounts payable for the last half of June in the amount of \$130,979.96 be approved and a warrant be drawn on the City Treasury for the said amount.
