

Official proceedings of the City Council of the City of Marseilles of the meeting of August 4, 2021.

The City Council of the City of Marseilles met in the Marseilles Fire Department at the hour of 6:00 P.M. on August 4, 2021.

Pledge of Allegiance was said.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, Lewey, Schaefer, and Buckingham. Absent: None.

Public Hearing was held regarding Housing Rehabilitation Program. Shug from NCICG explained the housing grant the city was awarded. The city was awarded \$393,300 additional funds were donated, City of Marseilles \$10,000, Ottawa Savings Bank \$5,000, Marseilles Bank \$2,500, Nucor \$2,500 this allowed 10 houses to be rehabbed. Total federally funded project was \$413,300. No person was relocated due to the project. Public hearing closed at 6:10 P.M.

Moved by Commissioner Kaminski seconded by Commissioner Lewey that the minutes from the council meeting on July 21, 2021 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Schaefer that the payroll for the last half of July in the amount of \$69,858.91 be approved and warrants be drawn on the city treasury for the several amounts. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Mayor Hollenbeck seconded by Commissioner Buckingham that Resolution 2021-23, a resolution reappointing Dee Crashaw and Janice Brozovich to the Marseilles Library Board be adopted. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Lewey seconded by Commissioner Kaminski that Ordinance 1803, an ordinance amending the City of Marseilles zoning ordinance relevant to general provisions for all resident districts be adopted. Pole barns will require a conditional use permit. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Commissioner Schaefer said the 2021 street resurfacing project has started. August 10, 2021 will be the last day the pool is open. Weekends will be open weather permitting and enough staff until Labor Day. Cleanup days will be held October 21-23 at the city garage. City Engineer said the boat launch project has started the cost will increase due to the soil being to moist.

Bob Davis asked the council to stop the water and sewer project going north due to the cost burden put on the residents of Marseilles.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the city council adjourn to executive session authorized under section 2 (C) 2 Personnel of the Open Meetings Act and to approve executive session minutes.
