The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on October 20, 2021.

Moved by Commissioner Kaminski seconded by Commissioner Lewey that the minutes from the Council meeting of October 6, 2021 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the accounts payable for the first half of October in the amount of \$974,682.55 be approved and a warrant be drawn on the City Treasury for the said amount.
