

Official proceedings of the City Council of the City of Marseilles of the meeting of November 17, 2021.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on November 17, 2021.

Pledge of Allegiance was said.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, Lewey, Schaefer, and Buckingham. Absent: None.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the minutes from the council meeting of November 3, 2020 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Schaefer that the accounts payable for the first half of November in the amount of \$126,442.56 be approved and a warrant be drawn on the City Treasury for the said amount. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the payroll for the first half of November in the amount of \$74,425.21 be approved and a warrant be drawn on the City Treasury for said amount. Kevin Lindeman from NCICG discussed the Main Street beautification grant the City is applying for. Deadline is January 10, 2022, will find out within 90 days or after and the money will be used for Main Street, lighting, new curbing, and sidewalks.

Moved by Mayor Hollenbeck seconded by Commissioner Lewey that Resolution 2021-33, a resolution directing the sale of the vacant lot at Capras Lane and East Broadway

Street in Marseilles be adopted. Ayes: Commissioners Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Mayor Hollenbeck seconded by Commissioner Lewey that Resolution 2021-34, a resolution directing the sale of the vacant city property not needed for Commercial Street right of way be adopted. Ayes: Commissioners Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.
