

Official proceedings of the City Council of the City of Marseilles of the meeting of December 1, 2021.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on December 1, 2021.

Pledge of Allegiance was said.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, and Lewey. Absent: Commissioner Schaefer.

Moved by Commissioner Kaminski seconded by Commissioner Lewey that the minutes from the Council meeting of November 17, 2021 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Buckingham seconded by Commissioner Lewey that pay estimate number 6 in the amount of \$72,655.89 to Advanced Asphalt for the Fillebrowne Street be approved. Ayes: Commissioner Kaminski, Lewey, Buckingham, and Mayor Hollenbeck. Nays: None.
