

Official proceedings of the City Council of the City of Marseilles of the meeting of January 19, 2022.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on January 19, 2022.

Moved by Commissioner Kaminski seconded by Commissioner Schaefer that the minutes from the Council meeting of January 5, 2022 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Buckingham that the accounts payable for the first half of January in the amount of \$309,744.29 be approved and a warrant be drawn on the City Treasury for the said amount.
