

Official proceedings of the City Council of the City of Marseilles of the meeting of April 20, 2022.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on April 20, 2022.

Pledge of Allegiance was said.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, Lewey, Schaefer, and Buckingham. Absent: None.

Chief Faber presented Kaylee White with an award for saving her father's life with the help of first responder Stacy Fuentes. Kaylee was instructed to give chest compressions while waiting EMS. The firefighters, EMS, and Police Officers involved were given a plaque for saving Jim White's life.
