

Official proceedings of the City Council of the City of Marseilles of the meeting of September 21, 2022.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on September 21, 2022.

Andy from Hitchcock design gave a presentation regarding Broadway Street OSLAD Grant. He was looking for community input to see what the residents would like to have at the park. The grant is due September 30, grant could pay up to \$600,000 City portion would be \$250,000. Drawings show a splash pad, pavilion, new playground equipment, basketball courts, pickle ball courts, sensory play area. Handicap equipment will be installed along with 16 parking spaces.
