

Official proceedings of the City Council of the City of Marseilles of the meeting of April 5, 2023.

The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on April 5, 2023.

Pledge of Allegiance was said.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, Lewey, Schaefer, and Buckingham. Absent: None.

Moved by Commissioner Lewey seconded by Commissioner Schaefer that the minutes from the council meeting on March 15, 2023 be approved as displayed and placed on file. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Schaefer that the accounts payable for the last half of March in the amount of \$320,698.24 be approved and warrants be drawn on the city treasury for the several amounts. Ayes: Commissioner Kaminski, Lewey, Schaefer, Buckingham, and Mayor Hollenbeck. Nays: None.

Moved by Commissioner Kaminski seconded by Commissioner Lewey that the payroll for the last half of March in the amount of \$76,914.13 be approved and warrants be drawn on the city treasury for the several amounts. Moved by Mayor Hollenbeck seconded by Commissioner Kaminski that Ordinance 1820, an ordinance accepting bid and approving sale of 1028 Catalpa Street be adopted. Moved by Mayor Hollenbeck seconded by Commissioner Kaminski that Ordinance 1838, an ordinance amending the City of Marseilles zoning ordinance amending authorized conditional uses in the conservation-recreation district be adopted.
