- Approved minutes from previous council meeting of 10-18-23
- Approved accounts payable in the amount of \$262.391.83. Within that number \$35,190.00 to the City of Ottawa quarterly payment to Central Dispatch for dispatching services. \$5,829.63 Ferguson Waterworks for water meters as the city continues to upgrade our system to radio readers. Atlanta National Bank G.O Debt Certification \$57,700.00. Homefield Energy (Illinois Power Marketing) \$22,242.08 for power bill.
- Approved a proposal from Renwick & Associates to conduct a lead water service line inventory report. The city received a 50k grant from the EPA to conduct this project as this is their mandate and the city was required to utilize a third party.
- Approved a Special Events Permit for Holiday Magic Lighted Santa Parage for Saturday December 2nd at Knudson Park.
- Approved final payment to John Pohar & Sons in the amount of \$91,402.83 for I-80 water and sewer construction. It is now completed.
- Adopted ordinance 1857 granting a variance for a driveway to Stephen Hlack for his property located at 707 Ryall Street.
- Mayor reported a coalition has been formed with Mendota, Peru, Streator, and Marseilles to submit Brownfield application this month. The grant will address Washington School and Nabisco properties to mediate environmental issues.
- The council met in executive session authorized under the open meetings act 2 (C) 1 Personnel and 2 (C) 5 Purchase of Property. No council action was taken upon the council reconvening to regular session.
