The City Council of the City of Marseilles met in the City Chamber of City Hall at the hour of 6:00 P.M. on March 6, 2024.

Roll call showed the following present: Mayor Hollenbeck, Commissioner Kaminski, Small, and Scheib. Absent: Commissioner Buckingham.
