Please provide the records in **digital format** (PDF, Excel, or MP3) if possible. If the audio files are too large to email, I am willing to receive them on a USB drive or via a secure file transfer link.

If any records are exempt from disclosure, please cite the **specific exemption under 5 ILCS 140/7**, and provide the remainder of the non-exempt information.

**Additional Notes:**

- I understand that some data may be redacted to protect private health or juvenile information, consistent with FOIA and HIPAA where applicable.
- If these records are held by the Marseilles Police Department or LaSalle County Dispatch, please forward the request as necessary, per **5 ILCS 140/3(d)**.

**Fee Waiver Request (if applicable):**
